**Registration, Evaluation, Authorization and Restriction of Chemicals (REACH)  
CERTIFICATE OF COMPLIANCE**

Dear Customer:

Mercury Tube Products, LLC products would be considered an article under REACH. An article is an object which during production is given a special shape, surface or design which determines its function to a greater degree than does its chemical composition (e.g. manufactured goods such as textiles, electronic chips, furniture, books, toys, kitchen equipment, tubing, metal and plastic components). Therefore our finished goods parts made of stainless steel would be considered as "articles".

REACH applies to chemical substance or products (called "articles" in the Regulation) that release chemicals into the environment during their normal use. REACH does not apply to solid raw materials such stainless steel in the form of tubing as end products. Therefore, as previously stated, our products are exempt from the REACH requirements and, therefore, by default would be in compliance with REACH regulations.

We declare that all tubing manufactured by Mercury Tube Products, LLC and packaging does not contain any of the Substances of Very High Concern (SVHC).
